#### ENTRY/REGISTRATION

On-line entry quick and easy or entry in paper form.

You can find all required information on [www.skchr.sk](http://www.skchr.sk).

After on-line entry you will receive e-mail with all required information to payment. After second deadline you will receive an entry confirmation.



Entry in paper form is possible at 1<sup>st</sup> entry deadline.

#### CLASSES:

(for inclusion of the dog to class is decisive age of the dog is the age on the day of the show)

PET class	from 3 months (for all pet dogs with pedigree)
Minor puppy class	from 3 to 6 months
Puppy class	from 6 to 9 months
Junior class	from 9 to 18 months
Intermediate class	from 15 to 24 months
Open class	from 15 months, it is accessible to all dogs regardless to passed working exams or achieved championships
Working class	from 15 months, it is accessible to all dogs with a working certificate issued by SPZ
Champion class	from 15 months, it is accessible to all dogs which obtained title C.I.B or champion title from any member country of FCI
Veteran class	from 8 <sup>th</sup> year
Honorary class	out of competition, in this class you can show dogs without qualification with awarding marks and ranking. Accessible to all dogs with recognized national or international champion title, the title of national winner, club winner, specialty winner or champion SKCHR. Listed titles shall to be obtained in adult competition. Dogs in this class are shown without CAC, Winner of the Specialty Show, J-BOB, V-BOB, BOB

#### TITLES AND CERTIFICATES:

**CAC/res. CAC** - the qualifying certificate for the Slovak Champion title

**CAJC** – the qualifying certificate for the Slovak Junior Champion title

**Club.CAC/res.Club.CAC** – the qualifying certificates for the SKCHR Champion title, only for dogs owned by SKCHR club members

**Junior winner of the specialty show** - title can be awarded to the best junior male and female in the junior class in competition excellent 1 CAJC

**Winner of the specialty show** - title can be awarded to the best male and female in the intermediate, open, working and champion class in competition excellent 1 CAC

**BOV – Best veteran** - title can be awarded to the best male or female in the veteran class in competition excellent 1

**BOB – Best of breed** - the Junior winners of the specialty show, the Winners of the specialty show and best veteran will compete for BOB

**BOS – Best opposite sex** - the Winners of opposite sex of BOB will compete for BOS

**Best baby** – title can be awarded to the best male or female in the minor puppy class in competition very promising 1

**Best puppy** - title can be awarded to the best male or female in the puppy class in competition very promising 1

**Best PET** - title can be awarded to the best male or female in the PET class

## COMPETITIONS:

Entered dogs must be judged at Specialty show.

**Child and dog/Junior Handling** – Criteria being judged: team-work of child and dog, synchronization and handling, Quality of the dog is not decisive. Handled dog have been judged at this show. Children to the age of 17 can enter this competition.

**Best young head male/female** – Males and females to 15 months are judged separately. Dog's head is judged in sitting position.

**Best adult head males/female**– Dogs and females under 15 months are judged separately, dog's head is judged in sitting position.

**Best ridge** – Males and females are judged together. Dog's ridge is judged in sitting position.

**Best movement** – Males and females are judged together. Criteria being judged: quality, elegance and dynamics of movement with an emphasis on proper mechanics of movement.

**Best couple** – One owner can enter his/her male and female that have been judged at this show and are in same ownership, not a co-owner. Owner must be indicated in the pedigree.

**Best breeder's group** - A breeder can enter his/her breeder's group of min. 3 max. 5 dogs, which have been judged at this show. The dogs and bitches do not have to be owned by the breeder, but they must come from same kennel from at least two different litters, at least two different sires or dams. A dog can only be entered to one breeder's group.

**Best stud dog** - The competition enters the dog and at least 5 his progeny, which have been judged at this show. Criteria being judged: the type and the quality of progeny. Stud dog doesn't need to be judged at this show in competition.

There is no pretension for any of the Titles – the judges have the right not to award any of the titles.

A judge is obliged to disqualify aggressive dogs.

## VETERINARY RULES

Every dog must have pet pass with valid vaccinations against rabies, distemper, parvovirus and hepatitis at least 21 days and a maximum 1 year before show, or according to duration of vaccine.

## GENERAL PROVISIONS

The show is held under the FCI, SKJ and SKCHR show regulations. Imported dogs must be registered with the stud book in the country of residence of the owner. Exhibitor is responsible for all data written in application form.

Upload entry form to online system or signing the form exhibitor abides to all dog show rules (FCI, SKJ, SKCHR) and veterinary rules. The exhibitor is giving his/her permission to publish his/her name and address in the exhibition catalog and on the website of the organizer as well as pictures from the exhibition on the website of the organizer and in magazines, where reports from exhibition.

The exhibitor is required to pay all show fees.

Neither the show committee nor organizer take responsibility for a dog's illness, dog's loss or death and neither they take responsibility for damage caused by a dog or an exhibitor in the venue area. The owner is responsible for any damages caused by the dog. Should the show not be held for the unforeseen reasons, the exhibition fees will be used to cover the expenses.

It's possible to entry competitions and pay at the day of the show till 13:30 to the cashier. The amounts are as of the date of the second closing.

In case of high number of registered dogs of one owner to classes pet, minor puppy, puppy, veteran and honorary they are not considered for first registered dog. Discount for second and any additional dog can be applied only if name of the owner is fully consistent with registration of the first dog. The closing date is also the deadline for payment exhibition fees to the appropriate deadline. Cancellation of registration is allowed till 2<sup>nd</sup> deadline, also in case if it is prolonged. Change of class is also allowed till 2<sup>nd</sup> deadline, for a fee 5 €.
